Re: Invitation to Technical Meeting on Loss Factor Activities Under Section 501.10 of the ISO Rules, *Transmission Loss Factors* ("Loss Factor Rule")

As discussed in the AESO's update on loss factor activities dated May 16, 2019, the AESO validated revisions to the loss factor calculation scripts in May and June 2019. The revised scripts were then used to calculate 2019 loss factors which were published on the AESO website on June 27, 2019.

In response to questions from the City of Medicine Hat on the 2019 loss factors, the AESO has identified a data misalignment resulting from certain files reflecting daylight saving time while all other files reflected standard time. The AESO has corrected the misalignment and is currently re-running the 2019 loss factor calculations. Corrected 2019 loss factors will be published the week of July 15-19.

The AESO invites registered participants in Proceeding 790 and other interested parties to attend a loss factors technical meeting after the corrected loss factors are published. The AESO will present information on the 2019 loss factors and other loss factor activities at the following meeting:
