Re: Invitation to Technical Meeting on Loss Factor Activities Under Section 501.10 of the ISO Rules, Transmission Loss Factors ("Loss Factor Rule")

On November 21, 2019, the AESO published loss factors for 2020, together with additional information used to establish the loss factors. On December 3, 2019, the AESO filed an application to the Alberta Utilities Commission to review Decision 790-D06-2017, which ordered the AESO to use a single settlement approach, and vary the decision by ordering the AESO to use a "pay-as-you-go" settlement approach.
