

# Information Document ISO Tariff - Bill Estimator Calculator ID #2025-015T

# 1 Purpose

This information document relates to the following authoritative documents:

- Rate DTS of the ISO tariff, Demand Transmission Service and its predecessor documents<sup>2</sup> ("Rate DTS");
- Rate PSC of the ISO tariff, Primary Service Credit and its predecessor documents ("Rate PSC");
- Rate STS of the ISO tariff, Supply Transmission Service and its predecessor documents ("Rate STS");
- Rider C of the ISO tariff, Deferral Account Adjustment Rider and its predecessor documents ("Rider C");
- Rider E of the ISO tariff, Losses Calibration Factor Rider and its predecessor documents ("Rider E");
- Rider F of the ISO tariff, *Balancing Pool Consumer Allocation Rider* and its predecessor documents ("Rider F"); and
- Rider J of the ISO tariff, *Wind Forecasting Service Cost Recovery Rider* and its predecessor documents ("Rider J").

The purpose of this information document is to provide market participants with a tool to estimate monthly charges for system access service pursuant to the ISO tariff rates and riders listed above.

# 2 Completing the Bill Estimator Calculator

### 2.1 General Information

The bill estimator calculator provided in Appendix 1 is an optional tool that a market participant may use to estimate monthly charges for its system access service. This section of the information document outlines instructions for market participants that choose to use this tool and, where applicable, information to assist the market participant in determining appropriate values to enter.

In Appendix 1, enter values in the cells highlighted in yellow only in the *A - Inputs and Summary* worksheet ("*A - Inputs and Summary*" sheet) and, if applicable, in the *B - Rate DTS and Riders* worksheet ("*B - Rate DTS and Riders*" sheet). The calculator uses these values to estimate the market participant's monthly charges for system access service.

The AESO has provided messages related to the market participant and calculation preparation in the cells where values are entered. When the market participant enters values into these cells, those values will replace the default text.

When the market participant selects options from the dropdown menus in rows (a) to (h) of the A – Inputs and Summary sheet, its selection may cause hatched cells to open for entry in rows (i) to (aa) of the A –

*Inputs and Summary* sheet and cells "F51" to "F55" of the *B* – *Rate and Riders* sheet.

## 2.2 Applicable ISO Tariff

The Rate DTS, Rate STS, and Rate PSC rates and related riders used to estimate the monthly charges for system access service are set out in the respective rate and rider sections of the ISO tariff, which are outlined in section 1 of this Appendix.

Each market participant is billed in accordance with the ISO tariff in effect at time of billing. For information purposes, the *Bill Estimator Calculator* provides the market participant with the option to estimate its bill based on previous ISO tariffs.<sup>3</sup>

In the calculator, the market participant selects the ISO tariff version from the dropdown menu of cell "K10" of *A – Inputs and Summary* sheet, which is shown in cell "K11". The *Bill Estimator Calculator* values change based on this input, including the rates and riders used to calculate the estimated monthly charges for system access service. By default, the calculator selects the most recent ISO tariff in effect.

#### 2.3 Estimate Details

The market participant provides details of its bill by selecting applicable choices from the dropdown menus in rows (a) to (h) of the A – Inputs and Summary sheet. The bill estimator calculator input cells on the A - Inputs and Summary sheet, as well as calculations on other Appendix 1 worksheets, change based on the market participants selections.

## 2.4 Billing Determinants and Riders

The market participant enters all amounts related to their billing determinants in rows (i), (k), (l), (n), (p), (q), and (u) of the A – Inputs and Summary sheet.

To assist the market participant in estimating its monthly charges for system access service, the average annual pool price is provided in row (s). The market participant may override the value in row (s) and input a pool price if it would like the calculator to use an alternative pool price. The AESO's average annual pool price is also available in the AESO's *Business Plan and Budget Proposal*<sup>4</sup> for the applicable year.

If applicable, the market participant enters its location-specific loss factor in row (v) and Rider E in row (y). The annual location-specific loss factors are available in the AESO's annual *Loss Factors* document for the applicable year. The quarterly location-specific Rider E calibration factor estimate can be found in the AESO's quarterly *Rider E Estimate* document for the applicable quarter. Refer to subsection 4.3 in this information document below for further information about the calculation of the loss factor and calibration factor charges.

Under Rate STS of the ISO tariffs from 2014 to 2020, a regulated generating unit connection charge was included on applicable market participant bills. <sup>7</sup> As a result, when the market participant selects the ISO tariff for the years 2015 to 2020, in cell "K11", the market participant may enter the regulated generating unit portion of its Rate STS contract capacity, in MW, in row (w). These provisions are no longer needed and were removed from Rate STS in the 2021 ISO tariff.

The market participant may enter amounts for Rider C in cells "F51" to "F55" of the B-Rate and Riders sheet. The calculator sets all the amounts for Rider C as zero by default. The quarterly Rider C charge or

credit values are available in the AESO's quarterly Rider C Charge or Credit Calculations document.8

#### 3 Bill Estimate Results

After the market participant enters or selects all relevant values on the A-Inputs and Summary and B-Rate and Riders sheets, the calculator calculates and summarizes the monthly estimate of charges for system access service. The summary of the monthly estimate of charges for system access service is presented on the A-Inputs and Summary sheet. More detailed results of Rate DTS and associated riders, Rate PSC and associated riders, and Rate STS and associated riders can be found on the B-Rate DTS and Riders sheet, the Appendix 1 worksheet C-Rate PSC and Riders sheet), respectively.

### 4 Calculator Limitations

The *Bill Estimator Calculator* estimates market participant charges differently than is calculated on a market participant's actual monthly bill for the following 3 of the monthly charges: Rate DTS operating reserve charge; Rate DTS transmission constraint rebalancing charge, and Rate STS loss charge. For these charges, the calculator is limited in that it uses the average monthly values, or approximations, to calculate some bill charges whereas, prior to billing, the AESO calculates the charges using actual hourly values once that information is available. The difference between the *Bill Estimator Calculator* estimation and the AESO's calculation of these charges are further described in the subsections below.

## 4.1 Rate DTS, Operating Reserve Charge

For each market participant with a Rate DTS contract capacity, the *Bill Estimator Calculator* approximates the operating reserve charge by using a percentage of the average annual pool price multiplied by the metered energy consumed by the market participant over the settlement period, in \$/MWh. This is different than the AESO's determination of each market participant's operating reserve charge which, pursuant to subsection 4(1) of Rate DTS, the AESO calculates for each hour of the settlement period.

Refer to information document #2011-004T, *Operating Reserve Charge Calculation*,<sup>9</sup> for more information.

# 4.2 Rate DTS, Transmission Constraint Rebalancing Charge

For each market participant with a Rate DTS contract capacity, the *Bill Estimator Calculator* approximates the transmission constraint rebalancing charge by assuming a constant total transmission constraint rebalancing payment over the total metered energy for all Rate DTS and Rate FTS market participants over a settlement period, in \$/MWh. This is different than the AESO's determination of each market participant's transmission constraint rebalancing charge which, pursuant to subsection 5 of Rate DTS, the AESO calculates for each hour of the settlement period.

# 4.3 Rate STS, Loss Charge

For each market participant with a Rate STS contract capacity, the *Bill Estimator Calculator* approximates the losses charge by assuming a constant metered energy produced multiplied by the average pool price

multiplied by a loss factor for the facility. This is different than the AESO's determination of each market participant's loss charge which, pursuant to subsection 2(1) of Rate STS, the AESO calculates on an hourly basis.
